## Atharva Folk Fest – State-wise Folk & Tribal Music Series

Since many State Governments presently do not have a structured support mechanism for folk and tribal music festivals, **CRPIM will assume this crucial role** by curating, organising, and promoting authentic folk festivals across India.

### **Proposed Model**

- CRPIM will create a unified brand titled **Atharva Folk Fest**, under which **state-specific editions** will be organized.
- Each edition will showcase the unique folk culture, music traditions, instruments, and performers of that particular state.

  - o Atharva Folk Fest (Tribal & Adivasi Music State Edition)

#### **CRPIM's Role**

- Identify genuine folk and tribal musicians from each state.
- Curate performances representing diverse traditions such as lavani, powada, tamasha, bhajan, kalbeliya, manganiyar, baul, bihu, bhairavi tribals, gondwana traditions, and many more.
- Offer financial support, artist honorarium, event design, and promotion through CRPIM's platforms.
- Collaborate with state cultural departments wherever possible to strengthen regional outreach.
- Document and archive performances for preservation and academic research.
